ARTICLES OF CONVERSION
OF
REMAC, INC. TO REMAC, L.P.

Pursuant to Articles 5.18 of the Texas Business Corporation Act, Remac, Inc, a Texas Corporation, ("Converting Entity") is converting to Remac, L.P., a Texas Limited Partnership, ("Converted Entity") and executes these articles of conversion certifying the following:

Article I

Parties to the Conversion

1.1. **Converting Entity.** The Name of the Converting Entity is Remac, Inc., a Corporation Incorporated under the laws of the State of Texas.

1.2. **Converted Entity.** The Name of the Converted Entity will be Remac, L.P., a Limited Partnership formed under the laws of the State of Texas.

Article II

Approval of Conversion

2.1. **Approval by Shareholders.** A plan of conversion was approved by the Shareholders and Directors of the Converting Entity, December 20, 2001, in the manner prescribed by its constituent documents and the Texas Business Corporation Act. The conversion will become effective after filing the articles of conversion with Texas Secretary of State or on January 1, 2002 whichever is later.

2.2. **Availability of Copy of Plan of Conversion.** An executed copy of the plan of conversion is on file at 1445 Bradley Lane, Suite 105, Carrollton, Texas 75007, the principal place of business of the Converting Entity. An executed copy of the plan of conversion will be on file at 1445 Bradley Lane, Suite 105, Carrollton, Texas 75007, the principal place of

business of the Converted Entity from and after the conversion.

2.3. Request for Copy of Plan of Conversion. An executed copy of the plan of conversion will be furnished by the Converting Entity (prior to the conversion) or by the Converted Entity (after conversion) to shareholders or partners of either entity. The copy will be provided without cost, on the written request of partners or members.

2.4. Approval of Plan of Conversion. The number of shares of the corporation outstanding at the time of Conversion was 1,000; and the number of shares entitled to vote as a class thereon was 1,000 common shares. The designation and number of outstanding shares of each class entitled to vote thereon as a class were as follows:

3.1. The Converted Entity will be responsible for any franchise taxes of the Converting Entity.

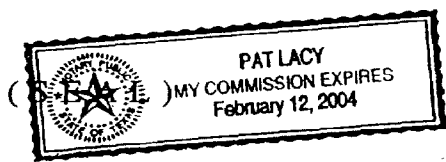
