RELEASE OF TRADEMARK SECURITY AGREEMENT

RELEASE, dated May 30, 1997 granted by State Street Bank And Trust Company, 225 Franklin Street, Boston, Massachusetts 02110, a Massachusetts Corporation ("State Street").

WITNESSETH:

WHEREAS, TSR, Inc., 201 Sheridan Springs Road, Lake Geneva, Wisconsin 53147, a Michigan Corporation ("TSR") and State Street, have entered into a Trademark Security Agreement, (the "Trademark Security Agreement"), pursuant to which TSR granted to State Street a security interest in all of the Trademarks and Licenses (as such terms are defined in the Trademark Security Agreement);

WHEREAS, the following Trademark Security Agreements were recorded with the United States Patent and Trademark Office on: September 19, 1990, on Reel/Frame Number 0739/0917; June 19, 1996, on Reel/Frame Number 1519/0350; and January 13, 1997 on Reel/Frame Number 1544/0481 with respect to the United States trademarks listed on Schedule "A" attached hereto and forming a part hereof (the "Schedule A");

NOW, THEREFORE, for good and valuable consideration receipt of which is hereby acknowledged, State Street does hereby release, terminate, acquit, exonerate, forever discharge and, to the extent any interest was transferred, reassign to TSR its entire right and interest in the U.S. trademarks listed on Schedule "A", created by the Trademark Security Agreement, and said Trademark Security Agreement, and the lien and security interest granted thereby to State Street shall hereupon cease and terminate.
