

FIRST: That this corporation was incorporated under the name BPI Acquisitions, Inc. on the 11<sup>th</sup> day of January 1994, pursuant to the Law of the State of Delaware. On February 22, 1994 the name was changed to BPI Communications Inc. On December 31, 2000, the name was changed to VNU Business Media, Inc.

SECOND: That this corporation owns all of the outstanding shares of the stock of BPI Communications, Inc., a corporation incorporated under the name New BPI, Inc. on the 11<sup>th</sup> day of December 2000, pursuant to the Law of the State of Delaware. 
RESOLVED, that VNU Business Media, Inc. will merge into itself said BPI Communications, Inc., and assumes all of its obligations;
