# TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("**Trademark Assignment**") is made and entered into as of May 13 2002, between Cosmyl, Inc., a corporation organized under the laws of the State of Florida, having its principal place of business located at 8055 Northwest 77<sup>th</sup> Court, Unit 5, Medley, Florida 33166 ("**Assignor**") and Prima Technologies, Inc., a corporation organized under the laws of Delaware, having its principal place of business at 110 Lake Avenue South, Suite 42, Nesconset, New York 11767 ("**Assignee**").

## Recitals

A. Assignor is the owner of the trademarks and trademark applications in the form more fully described in Exhibit A hereto (the "**Trademarks**");

B. Pursuant to the terms of a certain Settlement Agreement dated May 13, 2002 (the "**Settlement Agreement**") by and between Assignor and Assignee, Assignor has agreed to assign to Assignee all of Assignor's right, title, and interest in and to the Trademarks, together with the goodwill associated therewith; and

C. Assignee now desires Assignor to execute and deliver to Assignee this Trademark Assignment to effect the assignment of the Trademarks to Assignee in accordance with the Settlement Agreement.

## Agreement

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. In connection with the Settlement Agreement, Assignor hereby sells, transfers, conveys, assigns, and sets over unto Assignee, its successors and assigns, Assignor's entire right, title and interest in and to the Trademarks and all phonetically similar marks, including, without limitation, all registrations and applications therefor and the right to apply for and register the Trademarks, in the United States of America and all foreign countries, together with the goodwill of Assignor's business in which the Trademarks are used and symbolized by the Trademarks, all common law and statutory rights related thereto, all rights of renewal and extension, and the right to recover for damages and profits for past infringements thereof.




