Assignment

ASSIGNMENT made this 26th day of April, 2002, by and between WOODWORKERS WAREHOUSE, a corporation of the State of Delaware, with a principal address at 126 Oxford Street, Lynn, Massachusetts 01901-1132 ("Assignor"), and THE SPORTS AUTHORITY MICHIGAN, INC., a corporation of the State of Michigan, with a principal address at 3383 North State Road 7, Fort Lauderdale, Florida 33319 ("Assignee").

WHEREAS, Assignor owns the trademark and service mark GOLF DAY which is the subject of U.S. Trademark Reg. No. 1,226,392, issued February 8, 1983, used with "*repair and refinishing material for wood golf clubs – namely, stains, fillers, dip coatings, sealers and spray finishes,*" in Class 2, and "*strippers for wood golf clubs,*" in Class 3, as well as common law rights for use of the same mark in connection with "*retail store services, mail order services, and telephone order services for sporting goods, sports and exercise equipment, sports accessories, sports teaching aides, clothing and accessories, golf shoes and golf shoe accessories, outerwear, head-wear, eyewear, golf mittens and golf gloves, golf cart accessories, tennis rackets, tennis accessories, cigar accessories, umbrellas and braces,*" in Class 35 (all rights of Assignor relating to the mark GOLF DAY, including without limitation the mark, the foregoing registration therefor, and all common law rights associated therewith shall be referred to collectively as the "Mark"); and

WHEREAS, Assignee desires to acquire the Mark and the goodwill of the business associated therewith;

NOW, THEREFORE, in consideration of One Dollar (\$1.00) and other valuable consideration, the receipt of which is hereby acknowledged, Assignor conveys, transfers, and assigns to Assignee all of its rights, title, and interest in and to the Mark together with the goodwill of the business symbolized thereby.

Assignor further assigns to Assignee all rights to sue for and receive all damages occurring from past infringing uses of the Mark.

Assignor agrees that upon request by Assignee, Assignor shall execute all papers, make all rightful oaths, testify on behalf of Assignee and do all other lawful acts necessary to carry out the intent of this Assignment at Assignee's expense and request, including recordal of the Assignment, as well as provide such other material, information, or assistance as Assignee may consider necessary.

This Assignment shall be binding on the parties, their successors and/or assigns and all others acting by, through, with, or under their direction, and all those in privity therewith.
