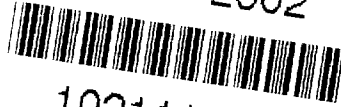

Pursuant to the provisions of Art. 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE ONE. The name of the corporation is Chemitreat Services, Inc.

ARTICLE TWO. The following amendment to the Articles of Incorporation was adopted by the sole shareholder of the corporation on March 31, 1998.

Article I of the Articles of Incorporation is hereby amended so as to read as follows:


The name of the corporation is C'treat Offshore, Inc.
