



TRADEMARK ASSIGNMENT

WHEREAS, Nordstrom, Inc., a corporation of the State of Washington, with its principal place of business at 1700 Seventh Avenue, 8<sup>th</sup> Floor, Seattle, Washington 98101 ("Assignor"), is the owner of U.S. Trademark Registration No. 1,410,591, registered September 23, 1986 for "GANG" ("the Mark") in connection with "women's sportswear, namely, blouses, pants, shorts, sweaters, jackets, and playsuits ("the Registration"); and

WHEREAS, C.P.I. Comercio de Roupas, Ltda., a Brazilian corporation, with its principal place of business at Av. Suburbana 5474 loja 410 2° Piso, Cachambi, 20951 Rio de Janeiro, RJ, Brazil, ("Assignee"), desires to acquire the Mark and the above-referenced Registration;

NOW THEREFORE, in consideration of the mutual promises contained in this Agreement including payment of the sum of \$15,000.00, due and payable upon the execution of this Agreement, Assignor hereby sells, assigns and transfers to Assignee all its right, title and interest in and to the Mark in the United States and the Registration therefor, together with the goodwill of the business symbolized thereby, under the following terms:

1. Assignee will make payment of the sum of \$15,000 upon the effective date of the agreement set forth below;
  2. Assignor makes no representations regarding the validity or enforceability of its rights in the Mark or the Registration, and assigns its rights on an "as is", "quit claim" basis;
  3. Assignor agrees to transfer to Assignee's counsel, within thirty (30) days of the execution of this Assignment, its corporate file and its trademark counsel's file for the Registration;
  4. Assignee agrees to refrain from involving Assignor in any disputes relating to the Mark, and to take all reasonable steps necessary to keep other parties from involving Assignor in any disputes relating to the Mark;

5. Assignee will reimburse and indemnify Assignor for its direct and reasonable costs and time (include the reasonable cost of Assignor's employees time and any attorneys' fees and costs) involved in the event that Assignor or its counsel be required to participate in any dispute involving the Mark, including but not limited to in the following forms: (1) to give deposition testimony; (2) to produce documents under document production request or respond to other discovery requests; (3) to attend any proceedings in a court or other forum or prepare or assist in the preparation of filings in such proceedings; or (4) to consult with or assist Assignee or its counsel;
6. Assignee will deposit with the firm of BIRCH, STEWART, KOLASCH & BIRCH, LLP, ("BSKB") 8110 Gatehouse Road, Suite 500 East, Falls Church, Virginia, 22042, upon the effective date of the agreement set forth below the additional sum of \$15,000.00, to be held in trust by BSKB for at least two (2) years from the effect date, unless sooner paid to Assignor;
7. In the event that Assignor is required to become involved in any dispute relating to the Mark as defined in paragraph 5, above, Assignee shall pay Assignor \$15,000.00. This payment shall be over and above Assignee's obligation to reimburse and indemnify under paragraph 5, above. Should Assignor become involved during the first two (2) years after the effective date, such payment shall be made to Assignee by BSKB. Otherwise, Assignee shall pay the entire \$15,000.00 amount directly to Assignor.

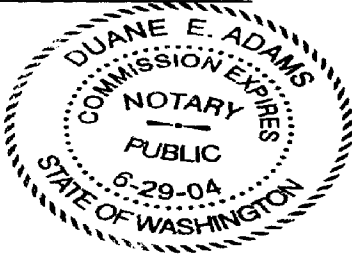
