WHEREAS, Fibred, Inc. (hereinafter "Assignor"), a corporation organized under the laws of the State of Maryland, and located at 543 National Highway, P.O. Box 3349, LaVale, Maryland 21504-3349 had adopted and used the mark FI-1 SOY FIBRE and design which registered on the Principal Register on July 4, 1995, and was assigned Registration No. 1,903,715, and had acquired goodwill in connection with such use; and

WHEREAS, Fibred-Maryland, Inc. (hereinafter "Assignee"), a corporation organized under the laws of the State of Maryland, and located at 543 National Highway, P.O. Box 3349, LaVale, Maryland 21504-3349, was formed on January 1, 1996, by a statutory merger of Fibred, Inc. and Ort's, Inc. and as a result acquired all rights, title, goodwill and interest in and to the trademark.
