

RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE, dated as of June 18, 1998 (this "Release"), is made by The Bank of Nova Scotia, as Administrative Agent, acting in its capacity as secured party (in such capacity, the "Secured Party") under that certain Trademark Security Agreement, dated as of January 26, 1996 (as supplemented by that certain Supplement to Subsidiary Security Agreement, dated as of June 4, 1996, and as further amended, supplemented, amended and restated, or otherwise modified from time to time, the "Trademark Security Agreement"), between Sunshine Biscuits, Inc., a Delaware corporation (the "Debtor"), and the Secured Party, which Trademark Security Agreement was recorded in the records of the United States Patent and Trademark Office;

W I T N E S S E T H:

WHEREAS, pursuant to the Trademark Security Agreement, the Debtor granted to the Secured Party a continuing security interest in, among other things, all of the Debtor's United States trademarks and trademark applications, including the trademarks set forth on Attachment 1 hereto (the "Trademarks");

WHEREAS, the Secured Party wishes to: (i) terminate the Trademark Security Agreement against the Trademarks identified in Attachment 1 hereto, as recorded with the United States Patent and Trademark Office; (ii) release all of its security interest covering the Trademarks; (iii) restore all right, title and interest in and to the Trademarks to the Debtor; and (iv) dissolve any and all liens and encumbrances respecting the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release its security interest in all of the trademarks of the Debtor, including the Trademarks set forth on Attachment 1 hereto, and discharges, quit claims and relinquishes unto the Debtor (in each case without recourse and without any representation or warranty) any and all rights, title and interest it has in and to the Trademarks, and more particularly hereby releases the security interest granted to the Secured Party in the Trademarks which was recorded in the United States Patent and Trademark Office.
