**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
SOFTWARE TECHNOLOGY, INC.**

Pursuant to the provisions of Chapter 607, Florida Statutes, and its Articles of Incorporation, the undersigned corporation adopts the following Amendment to its Articles of Incorporation, as originally filed with the Secretary of State of the State of Florida.

I. The name of the Corporation is Software Technology, Inc.

II. The following amendment to the Articles of Incorporation was adopted by the corporation:

A. Article I is hereby amended by altering it in its entirety so as to read:

“ARTICLE I - NAME OF CORPORATION

The name of this corporation is **EXIGENT SOFTWARE TECHNOLOGY, INC.”**

III. The amendment to the Articles of Incorporation was adopted pursuant to written consent in lieu of a meeting of all the Board of Directors and Shareholders duly considered and executed.
