ASSIGNMENT OF RIGHTS

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, MIGHTY MAIDS, INC., a Maryland corporation whose address is 9017 Red Branch Road, Suite G., Columbia, Maryland 21095, (the Assignor), hereby transfers, sells, and assigns to THE CLEANING AUTHORITY, INC., a Maryland corporation whose address is 9017 Red Branch Road, Suite G., Columbia, Maryland 21095 (the Assignee), all of its right, title, and interest in and to any and all patent rights, rights of copyright, trademark and service mark rights and all other proprietary rights of the Assignor; including without limitation all of the Assignor's right, title, and interest in and to the service mark "The Cleaning Authority" (Registration No. 2,237,954 Serial No. 75/146,496) and all the goodwill associated with such service mark (collectively, the Marks).

The Assignor hereby transfers, sells, and assigns to the Assignee all of its right, title, and interest in and to any and all registrations and applications for registration of the Marks, together with any and all extensions and renewals. The transfer, sale, and assignment of the Marks and the associated rights shall be deemed to include the right of the Assignee to sue for and collect damages and profits by reason of any past, present, or future infringement of any associated rights.

Upon the request of the Assignee, the Assignor shall take such actions and execute such documents and instruments as may be required in order for the Assignee to perfect, protect, enforce, transfer, or register the Marks or any associated rights.

The Assignor represents and warrants that: (a) it is the exclusive owner of the Marks; (b) the Marks are not subject to any liens, claims, charges, encumbrances, security interests, or restrictions of any kind whatsoever; (c) the Assignor has the right and authority to enter into this Assignment without receiving the consent or approval of any other person or organization, and (d) this Assignment shall be binding upon and fully enforceable against the Assignor.

This Assignment, together with the Transfer Agreement dated the date hereof between Assignor and Assignee, sets forth the entire understanding between the Assignor and the Assignee with respect to the subject matter of this agreement, there being no terms, conditions,

warranties, or representations other than those contained in this Assignment, and no amendment shall be valid unless made in writing and signed by the Assignor and the Assignee.
