## ASSIGNMENT - UNITED STATES TRADEMARKS

WHEREAS, ACCTECH, L.L.C., a New Jersey limited liability company, with its principal offices at 33 Murray Hill Drive, P.O. Box 547, Nanuet, New York, 10954 (the "Seller") has adopted and used in the United States the trademarks, and is the owner of United States trademark registrations and trademark applications set forth and described in Exhibit "A" hereto;

WHEREAS, the trademark registrations set forth and described in Exhibit "A" represent all registered United States trademarks used by the Seller in the Seller's business;

WHEREAS, Advantus, Corp., a Florida corporation (the "Purchaser"), is desirous of acquiring such marks and the goodwill of the business represented thereby.

NOW, THEREFORE, in consideration of and in exchange for the sum of ten dollars and other good and valuable consideration, the receipt of which is hereby acknowledged:

SELLER hereby sells, assigns, transfers and sets over unto Purchaser full, good and marketable ownership, right, title and interest in, to and under such trademarks together with the goodwill of the business represented by such trademarks, and all registrations and applications therefor, including any renewals and extensions of the registrations that are or may be secured under the laws of the United States, now or hereafter in effect, for Purchaser's own use and enjoyment, and for the use and enjoyment of Purchaser's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Seller if this Assignment and sale had not been made; together with all income, royalties or payment due or payable as of the Closing Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the trademarks, with the right to sue for, and collect the same for Purchaser's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

AND, Seller further covenants and agrees that it will, upon request and at Purchaser's expense, promptly provide the Purchaser with all pertinent facts and documents relating to said trademarks, trademark applications and rights as may be known and accessible to the Seller and will testify to the same in any interference or litigation relating thereto and will promptly execute and deliver to the Purchaser or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce, said trademarks and applications and said rights which may be necessary or desirable to carry out the purposes thereof.

AND, Seller hereby authorizes and requests the Commissioner of Patents and Trademarks to record Purchaser as assignee of the entire interest and owner thereof, and hereby covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreements inconsistent herewith.
