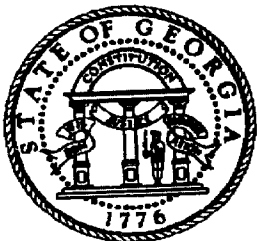

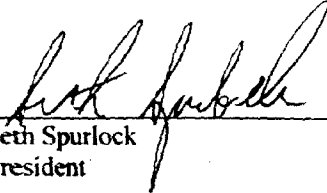

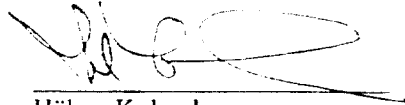
NOW, THEREFORE, BE IT RESOLVED, that the Articles of Amendment attached hereto as Exhibit A are hereby adopted and approved; and
