Trade Mark Assignment

THIS ASSIGNMENT is dated this 19TH day of JUNE 2002

BETWEEN:

1. G. W. & R. SHELTON LIMITED of Park Street, Wollaston, Northamptonshire NN9 7RR, United Kingdom (the "Assignor"); and
2. R. GRIGGS & COMPANY LIMITED of Nene Park, Station Road, Irthlingborough, Northamptonshire NN9 5QG, United Kingdom (the "Assignee")

WHEREAS:

- (A) The Assignor is the proprietor of the trade mark registered in the United States of America which is listed in the attached schedule (the "Trade Mark").
- (B) The Assignor has agreed to assign all its rights, title and interest in and to the Trade Mark to the Assignee for the consideration mentioned below.

NOW THIS ASSIGNMENT WITNESSETH as follows:

1. In consideration of the sum of ONE POUND STERLING (£1.00) now paid by the Assignee to the Assignor (the receipt of which sum the Assignor hereby acknowledges) the Assignor **HEREBY ASSIGNS** to the Assignee absolutely the Trade Mark and all and any rights in and to the Trade Mark and any common law rights and all the goodwill attaching to the Trade Mark.
2. This Assignment shall include the right for the Assignee to bring proceedings against any third party in respect of the Trade Mark (including proceedings against third party for infringement of the Trade Mark or for passing off or for otherwise infringing the rights of the Assignor in the Trade Mark. The Assignor agrees and undertakes to provide the Assignee (at its request) all such existence with any proceedings which

may be brought by or against the Assignee against or by any third party in relation to the Trade Mark and the Assignee shall indemnify the Assignor in respect of all costs and expenses (including reasonable legal costs) actually incurred by it in the providing the Assignee with such assistance.

3. The Assignor covenants that at the cost and request of the Assignor at any time and from time to time it will execute such deeds or documents and do such acts or things as may be necessary or desirable to give effect to this Assignment.
4. This Assignment shall be governed by and construed in accordance with the laws of England and the parties hereto submit to the exclusive jurisdiction of the English courts.
