RELEASE OF TRADEMARK COLLATERAL SECURITY AGREEMENT

This Release Agreement is made as of February 28, 2002, by and between Century Credit Business Corporation, (the "Assignee"), Wells Fargo Credit, Inc., ("Wells Fargo"), and Biocompatibles Eyecare Inc. (the "Assignor").

RECITALS

A. WHEREAS, the Assignor is the owner of certain trademarks (the "Trademarks") registered in the United States Patent and Trademark Office as set forth below:

B. WHEREAS, the Assignor and Assignee entered into a Loan and Security Agreement, dated June 25, 1999 (the "Loan and Security Agreement"), wherein the Assignor granted to the Assignee a security interest in certain collateral, including the Trademarks, owned by the Assignor; and

C. WHEREAS, the Assignor and Assignee entered into a Trademark Collateral Security Agreement, dated July 9, 1999, Special Power of Attorney, and Trademark Assignment of Security, dated July 9, 1999 (collectively, the "Trademark Agreements"), wherein the Assignor granted to the Assignee a security interest in the Trademarks owned by the Assignor; and

D. WHEREAS, the Assignee filed a Trademark Assignment of Security, dated July 9, 1999, with the United States Patent and Trademark Office on September 23, 1999, which is recorded at Reel/Frame: 001933/0061; and

E. WHEREAS, the Assignee and Wells Fargo entered into a Loan Sale Agreement, dated May 7, 2000, wherein the Assignee assigned to Wells Fargo all of its right, title and interest in and to the Loan Agreement, including the Trademark Agreement.

F. NOW THEREFORE, in consideration of the mutual covenants and agreements contained herein, and other goods and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:
