PLAN OF MERGER

PLAN OF MERGER approved on December 12, 2001 by resolution adopted by at least a majority vote of the members of the Board of Directors of PRIMEDIA Enthusiast Publications, Inc., a business corporation of the State of Pennsylvania, for the purpose of merging Cowles History Group, Inc., its wholly-owned subsidiary corporation, into PRIMEDIA Enthusiast Publications, Inc.

1. PRIMEDIA Enthusiast Publications, Inc., as the owner of all of the outstanding shares of Cowles History Group, Inc., hereby merges Cowles History Group, Inc. into PRIMEDIA Enthusiast Publications, Inc.

2. The separate existence of Cowles History Group, Inc. shall cease upon the effective date of the merger pursuant to the provisions of the Virginia Stock Corporation Act. PRIMEDIA Enthusiast Publications, Inc. shall continue its existence as the surviving corporation pursuant to the provisions of the laws of the Commonwealth of Pennsylvania.

3. The issued shares of Cowles History Group, Inc. shall not be converted in any manner, but each said share, which is issued as of the effective date of the merger shall be surrendered and extinguished.

4. The Board of Directors and the proper officers of Cowles History Group, Inc. and of PRIMEDIA Enthusiast Publications, Inc., respectively, are hereby authorized, empowered, and directed to do any and all acts and things, and to make, execute, deliver, file, and/or record any and all instruments, papers, and documents which shall be or become necessary, proper, or convenient to carry out or put into effect any of the provisions of this Plan of Merger or of the merger herein provided for.
