TRADEMARK

NUNC PRO TUNC TRADEMARK ASSIGNMENT

WHEREAS, Chinin U.S.A., Inc., an Illinois corporation located at 1010 Jorie Boulevard, Oak Brook, IL 60521 (hereinafter referred to as "Chinin"), and Knights Apparel LLC, a Nevada limited liability corporation, formerly located at 1010 Jorie Boulevard, Oak Brook, Illinois 60521, now located at 2221 Camden Ct., Suite 390, Oak Brook, Illinois 60523 ("Knights Apparel") wish to clarify the Assignment recorded by the U.S. Patent and Trademark Office ("PTO") on November 26, 2001 at Reel 2398/Frame 0665, regarding U.S. Trademark Appln. No. 75/819848 for the mark ACTIVE BY KNIGHTS ATHLETICS (the "Trademark"), which was referenced on the Recordation Form Cover Sheet filed on November 21, 2001 and recorded by the PTO, but which was not referenced in the accompanying Assignment document;

WHEREAS, on October 12, 1999, Chinin filed U.S. Trademark Application No. 75/819848 in the PTO, and Chinin was the owner of record of the Trademark;

WHEREAS, on February 22, 2001, Chinin entered into that certain Asset Purchase Agreement with Knights Apparel, pursuant to which Chinin assigned all of its right, title, and interest in and to Chinin's trademarks to Knights Apparel;

WHEREAS, Chinin and Knights Apparel wish to clarify that as of November 20, 2001, (which is the date that Knights Apparel signed the Statement of Use in Application No. 75/819848), Chinin did assign the Trademark to Knights Apparel and intended to make Knights Apparel the owner of record of the Trademark in the PTO; and

WHEREAS, Chinin and Knights Apparel wish to memorialize the Assignment of the Trademark from Chinin to Knights Apparel *nunc pro tunc*;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties acknowledge that as of November 20, 2001, Chinin did assign, transfer and sell unto Knights Apparel its entire right, title and interest in and to the above-identified Trademark, together with the goodwill symbolized by said Trademark, and all rights of action against third parties for past infringement thereof, the same to be held and enjoyed by Knights Apparel as fully and entirely as the same would have been held by Chinin had that transfer, assignment and sale not been made.
