BETWEEN:

- (1) **REED ELSEVIER PROPERTIES INC.**, a company incorporated in the state of Delaware, USA whose principal place of business is at 1105 North Market Street, Wilmington, Delaware 19801, USA (the "Assignor"); and
- (2) **OAG WORLDWIDE LIMITED**, a company incorporated in England and Wales (registered no 4226716), whose registered office is at Broadwalk House, 5 Appold Street, London EC2A 2HA (the "Assignee").

RECITALS

- (A) The Assignor is the registered proprietor of the registered trade marks and of the benefit of the applications for registrations of the trade marks set out in the schedule (together the "Trade Marks").
- (B) By an agreement (the "Sale Agreement") made between the Assignor, Reed Travel Group Limited, Reed Elsevier Inc., Reed Travel Group (Germany) GmbH, Reed Elsevier (UK) Limited and Repairglobe (as defined below) on 25 June 2001 the Assignor agreed to assign the Trade Marks to Repairglobe on the terms set out in this assignment.
- (C) For the purposes of clause 28.10 of the Sale Agreement, Repairglobe sent the Nominee Letter (as defined below) nominating the Assignee to be assigned Repairglobe's rights under the Sale Agreement.

THE PARTIES AGREE AS FOLLOWS:

1. DEFINITIONS AND INTERPRETATION

For the purposes of this deed the following words and expressions shall have the following meanings:

"**Business Day**" means any day other than a Saturday or Sunday or public holiday in England and Wales when banks are open for the transaction of normal business;

"**Nominee Letter**" means a letter dated 19 July 2001 sent by Repairglobe to The Company Secretary of Reed Elsevier (UK) Limited for the purposes of clause 28.10 of the Sale Agreement;

"**Repairglobe**" means Repairglobe Limited, a company incorporated in England and Wales (registered no 4154381) whose registered office is at Broadwalk House, 5 Appold Street, London EC2A 2HA.

2. ASSIGNMENT

2.1 In pursuance of the said agreement the Assignor does hereby assign with full title guarantee all of its right, title and interest to and in the Trade Marks, including all statutory and common law rights attaching thereto and the right to sue for past infringements and to retain any damages obtained as a result of such action, to the Assignee.

2.2 The Assignor confirms that this deed of assignment is made with the goodwill attaching to the Trade Marks and the goodwill of the business in which the Trade Marks have been used by the Assignor.

3. FURTHER ASSURANCE

The Assignor shall at the Assignee's expense do and execute or procure that there shall be done and executed all such documents, deeds, matters, acts and things as the Assignee may at any time require properly to vest the Trade Marks or any one or more of them in the Assignee or otherwise to give effect to this assignment and perfect the Assignee's title.

4. NOTICES

4.1 -A notice or other communication under or in connection with this deed of assignment (a "Notice") will be:

(a) in writing; and

(b) delivered personally or sent by first class post pre-paid recorded delivery (and air mail if overseas) or by fax to the party due to receive the Notice to the address set out in clause 4.3 or to another address, person or fax number specified by that party by not less than five Business Days' written notice to the other party received before the relevant Notice was despatched.

4.2 Unless there is evidence that it was received earlier, a Notice is deemed given if:

(a) delivered personally, when left at the address referred to in clause 4.3;

(b) sent by mail, except air mail, two Business Days after posting it; and

(c) sent by air mail, five Business Days after posting it.

- 5.1 This deed of assignment is governed by English law.
- 5.2 The courts of England have exclusive jurisdiction to settle any dispute arising from or connected with this assignment (a "Dispute").
- 5.3 The parties agree that the courts of England are the most appropriate and convenient courts to settle any Dispute and, accordingly, that they will not argue to the contrary.
- 5.4 The parties agree that the documents which start any actions, claims or proceedings ("Proceedings") and any other documents required to be served in relation to those Proceedings may be served on the parties in accordance with clause 4. These documents may, however, be served in any other manner allowed by law. This clause applies to all Proceedings wherever started.


