TERMINATION AND RELEASE OF SECURITY INTERESTS IN CERTAIN TRADEMARKS

TERMINATION AND RELEASE OF SECURITY INTERESTS IN CERTAIN TRADEMARKS (this "Release"), dated as of April 30, 2002, by TORONTO DOMINION (TEXAS), INC. (the "Administrative Agent").

WHEREAS, Entercom Communications Corp., a Pennsylvania corporation ("Entercom"), Entercom Denver, LLC, a Delaware limited liability company ("Entercom Denver"), and Entercom Denver License, LLC, a Delaware limited liability company ("Entercom Denver License", and together with Entercom and Entercom Denver, the "Buyer") are purchasing substantially all of the assets of Emmis Radio Corporation, an Indiana corporation, successor in interest by merger to Emmis Broadcasting Corporation of Denver ("Emmis Radio") and Emmis Radio License Corporation, a California corporation ("Emmis License", together with Emmis Radio, the "Seller") relating to Radio Broadcast Station KALC (FM) in Denver, Colorado, pursuant to an Asset Purchase Agreement, dated as of February 12, 2002, between the Buyer and the Seller;

WHEREAS, pursuant to the terms of the Fourth Amended and Restated Subsidiary Trademark Collateral Security and Pledge Agreement, dated as of December 29, 2000 (the "<u>Trademark Agreement</u>"), between Emmis Radio, the Administrative Agent and certain other parties thereto, and recorded with the U.S. Patent and Trademark Office at Reel 2236, Frame 0425, Emmis Radio granted to the Administrative Agent for the benefit of certain lenders a security interest in and lien on, and collaterally assigned to the Administrative Agent, the trademark identified on <u>Schedule A</u> attached hereto (such trademark referred to herein as the "<u>Named Trademark</u>"); and

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest and all of its right, title and interest in the Named Trademark as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, intending to be legally bound hereby, the Administrative Agent and the Seller hereby agree as follows:

- 1. Release and Assignment. The Administrative Agent hereby terminates and releases its security interest in and lien on the Named Trademark, and the Administrative Agent hereby assigns and transfers to Emmis Radio, without recourse, all of the Administrative Agent's right, title and interest in and to the Named Trademark and the related goodwill, effective as of the date set forth above.


