AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (hereinafter "Agreement"), made as of the 14th day of September 2001 (the "Effective Date"), by and between L.C. King's right, title, and interest in and to the Mark, together with the goodwill, if any, of the business symbolized thereby.
