Notice of Grant of Security Interest in Trademarks

NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (the "Notice"), dated as of June 4, 2002, made by Las Vegas Sands, Inc., a Nevada corporation and Venetian Casino Resort, LLC, a Nevada limited liability company (collectively "Grantors"), in favor of The Bank of Nova Scotia, a Canadian chartered bank, in its capacity as Intercreditor Agent under the Intercreditor Agreement (as such terms are defined in the Security Agreement) for and on behalf of U.S. Bank National Association, a national banking association, as the trustee for and on behalf of the Mortgage Note Holders under the Mortgage Notes Indenture (as such terms are defined in the Security Agreement) and the Intercreditor Agent (collectively the "Secured Parties").

WHEREAS, the Grantors are the owners of the United States trademarks and service marks set forth on Schedule 1 attached hereto, including the associated registrations and applications for registration (collectively, the "Trademarks"); and

WHEREAS, pursuant to the Security Agreement, dated as of the date hereof, between Grantors and Secured Parties (the "Security Agreement"), Grantors granted, assigned and conveyed to the Secured Parties a security interest in, and lien on, certain intellectual property owned by the Grantors, including the Trademarks and the goodwill of the business symbolized by the Trademarks (collectively, the "Trademark Collateral"); and

WHEREAS, the Grantors and Secured Parties wish to execute this Notice for purposes of filing the same with the United States Patent and Trademark Office (the "PTO") and any other relevant government authority to confirm, evidence and perfect the security interest in the Trademark Collateral granted pursuant to the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and subject to the terms and conditions of the Security Agreement, the Grantors hereby grant and convey to the Secured Parties a security interest in, and lien, on the Trademark Collateral.

The Grantors hereby acknowledge the sufficiency and completeness of this Notice to create the security interest in the Trademark Collateral and to grant the same to the Secured Parties, and the Grantors hereby request the PTO to file and record the same together with the annexed Schedule 1.

The Grantors and the Secured Parties hereby acknowledge and agree that the security interest in the Trademark Collateral may only be terminated in accordance with the terms of the Security Agreement.
