CONFIRMATORY TRADEMARK ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Assignor affirms that it has sold, assigned and transferred, and by this document does *nunc pro tunc* sell, assign, and transfer, as of April 19, 2002, to Assignee, its successors and assigns forever, all right, title and interest Assignor has in and to the Assignor’s Trademark, the registrations and applications therefor together with the goodwill of the Assignor’s business symbolized thereby, the same to be held and enjoyed by Assignee, its successors and assigns forever, as fully and entirely as the same could have been held and enjoyed by Assignor had this Assignment not been made.
