Pursuant to Section 1006 of the Iowa Business Corporation Act, the undersigned corporation adopts the following amendment to its Articles of Incorporation.

1. The name of the corporation is MultiSep, Inc.
2. Article I of the Articles of Incorporation of MultiSep, Inc. is hereby amended to read as follows:

ARTICLE I

The name of the corporation is CombiSep, Inc.

3. The amendment was adopted on June 25, 2001.
