NOW, THEREFORE, for good and valuable consideration paid to Assignor by Assignee, receipt of which is hereby acknowledged, Assignor hereby assigns, sells, transfers and sets over unto Assignee its entire right, title and interest in and to the intellectual property, including registered trademarks, identified in Schedule A attached hereto, along with the good will associated therewith, and further including the right to sue and recover for past damages.

ASSIGNOR hereby agrees that Assignee shall have the right to record this instrument of Assignment in the United States Trademark Office so as to establish Assignee as the owner of record of the assigned registered trademarks.

ASSIGNOR further agrees, at the request of the Assignee and without charge or cost to Assignee, to execute and have executed any and all other documents of any kind whatsoever, and to provide any information that is in Assignor's possession or under its control that may be reasonably required to carry out the terms and intent of this Assignment; and to fully cooperate with Assignee, as reasonably required, to enable Assignee to duly record this instrument of Assignment with the United States Patent and Trademark Office so that Assignee's ownership of the assigned trademark registrations and copyright registrations is duly made of record in the United States.
