
TRADEMARK ASSIGNMENT

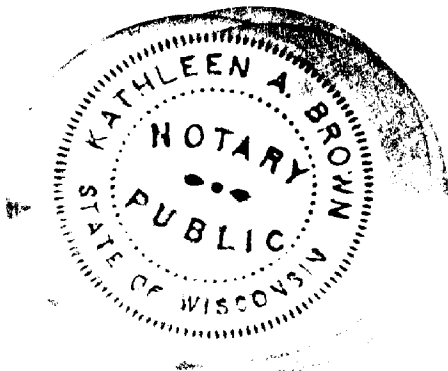
