RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST ("Release") is made as of June 5, 2002 by First Dominion Capital L.L.C. ("First Dominion"), 1330 Avenue of the Americas, New York, NY 10019.

WITNESSETH:

WHEREAS, First Dominion and Car Component Technologies, Inc. ("CCT"), 10 Iron Horse Drive, Bedford, New Hampshire 03110, a New Hampshire corporation, are parties to a certain Security Agreement dated as of February 18, 1999 ("Security Agreement"), pursuant to which CCT granted a security interest to First Dominion in certain collateral as defined in said Security Agreement, including the U.S. trademark registration listed in Exhibit I hereto;

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office at reel/frame 2056/0414;


