WHEREAS, on or about April 1999, Caradon Peachtree Marketing, Inc., changed its name to Peachtree Marketing, Inc. (as recorded in the U.S. Patent & Trademark Office on January 18, 2002; Reel/Frame 2435/0693);

WHEREAS, PEACHTREE MARKETING, INC. (formerly known as Caradon Peachtree Marketing, Inc.) is a wholly owned subsidiary of PEACHTREE DOORS AND WINDOWS, INC. ("Assignee");


WHEREAS, Assignee desires to acquire the Mark effective as of April 1, 2001;


