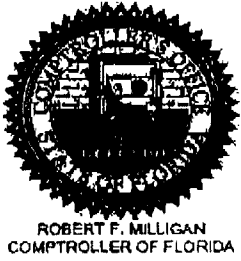

BY-LAW AMENDMENT, STATE CHARTER #670


This will certify that on December 20, 2001, at a meeting of the Board of Directors/Members of the Jax Navy Credit Union, called and held in accordance with the Credit Union's By-Laws, at which meeting a quorum was present, a resolution was adopted to amend Article 1, Section 1 of the present By-Laws to read as follows:

ARTICLE I, Section 1 - This Credit Union will be known as the VyStar Credit Union. Its principal place of business will be 4949 Blanding Blvd., Jacksonville, Florida 32210.

All other sections remain the same.


