## RELEASE OF TRADEMARK SECURITY INTEREST

This Release of Trademark Security Interest is made this 24<sup>th</sup> day of MAY, 2002 by Bank One, Wisconsin, as contractual representative (the "Agent") for its benefit of the "Holders of Secured Obligations" (as such term is defined in the "Credit Agreement" defined below).

WHEREAS, reference is made to a certain Credit Agreement, dated as of July 27, 2000, by and among the Kwik Trip, Inc., a Wisconsin corporation, HRZ, a Wisconsin general partnership, and ZRH, a Wisconsin general partnership, as borrowers (individually and collectively, the "Borrowers"), the financial institutions from time to time party thereto (the "Lenders"), and the Agent (as the same may have been modified, amended, restated or supplemented from time to time thereafter, the "Credit Agreement");

WHEREAS, Borrowers have fully paid the Obligations owing under the Credit Agreement, and Agent desire to release and discharge its security interest in the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the Agent hereby releases and remits to Borrowers any and all right, title and interest to its security interest in and to the Trademarks.
