

Under Section 242 of the General
Corporation Law of the State of Delaware

Barrister Information Systems Corporation, a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), DOES HEREBY CERTIFY:

FIRST: The Certificate of Incorporation of the Corporation shall be amended to change the name of the Corporation from BARRISTER INFORMATION SYSTEMS CORPORATION to BARRISTER GLOBAL SERVICES NETWORK, INC. To effect such amendment, Article 1 of the Certificate of Incorporation is hereby amended to read in its entirety as follows:

"1. The name of the corporation is BARRISTER GLOBAL SERVICES NETWORK, INC."

SECOND: The Board of Directors of the Corporation held a special meeting on March 30, 2000 whereby they unanimously voted in favor of adopting a resolution setting forth the amendment as set forth above, and declared its advisability. Such amendment has been duly adopted and approved by the holders of all of the issued and outstanding stock of the corporation at a special meeting of the stockholders held on May 5, 2000 in accordance with Sections 222 and 242(b) of the General Corporation Law of the State of Delaware.
