# TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT ("Agreement") is made as of November 14<sup>th</sup> 2001 between SPECTRACOM TECHNOLOGIES CORPORATION, an Ontario corporation ("SPECTRACOM") and ERGONOMIC ACCESSORIES INTERNATIONAL CORPORATION, an Ontario corporation ("ERGONOMIC").

## Recitals

A. SPECTRACOM is the owner of certain Canadian, United States and foreign trademarks and trademark applications (including any common law rights associated with the trademarks) (the "SPECTRACOM Trademarks") (A list of the SPECTRACOM Trademarks is attached hereto as Schedule 1).

B. SPECTRACOM is desirous of transferring to ERGONOMIC all of such right, title and interest to the SPECTRACOM Trademarks.

D. ERGONOMIC is desirous of obtaining all right, title and interest to the SPECTRACOM Trademarks from SPECTRACOM.

NOW THEREFORE, in consideration of the mutual covenants of the parties, each to the other, and of good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

### 1.1 TRADEMARK ASSIGNMENT

SPECTRACOM hereby does sell, assign and transfer to ERGONOMIC, its successors, assigns and legal representatives, the full and exclusive right to SPECTRACOM's worldwide right, title, and interest in and to the SPECTRACOM Trademarks, including the goodwill of the business symbolized by the SPECTRACOM Trademarks, and the applications and registrations therefore, and the right to sue for and collect damages for infringements and past infringements thereof.

### 2.1 RECORDATION

SPECTRACOM hereby authorizes and requests the Canada Trade Marks Office, the United States Commissioner of Patents and Trademarks and any other foreign trademark office to record this Assignment for the sole benefit of ERGONOMIC, its successors, assigns, and legal representatives.
