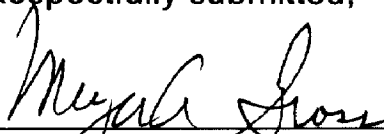
Applicant has reviewed the comments of the Examiner and has noted the favorable search results.

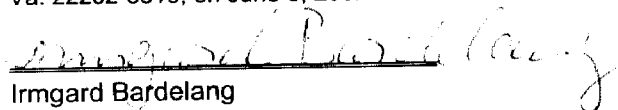

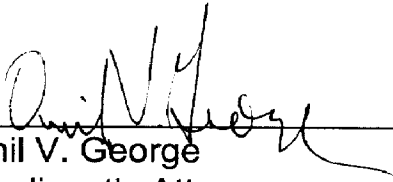
