Said amendment will not effect an exchange, reclassification or cancellation of the issued shares of the corporation.

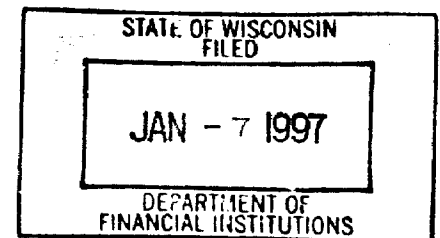
