


**ASSIGNMENT OF UNITED STATES TRADEMARK**

WHEREAS, COOPER INDUSTRIES, INC., an Ohio corporation having its principal offices at 600 Travis Street, Houston, Texas 77002, U.S.A., (the "ASSIGNOR") is the owner of the trademark and trademark registration listed in Schedule A attached hereto;

WHEREAS, COOPER CAMERON CORPORATION, a Delaware corporation, having its principal offices at 1333 West Loop South, Suite 1700, Houston, Texas, 77027, U.S.A., (the ASSIGNEE"), and ASSIGNOR have entered into an Asset Transfer Agreement dated January 1, 1995 (the "Asset Transfer Agreement") pertaining to the sale to the ASSIGNEE of certain assets of ASSIGNOR, including the trademark and trademark registration listed in the attached Schedule A together with the goodwill of the business in which the trademark is used.

NOW, THEREFORE, in consideration of the sum of U.S. \$10.00 (ten United States dollars) and pursuant to the Asset Purchase Agreement, ASSIGNOR hereby sells, assigns and transfers to ASSIGNEE, all of ASSIGNOR'S right, title and interest to the trademark and trademark registration listed in the attached Schedule A, together with the goodwill of the business in which the trademark is used. This assignment includes all of the ASSIGNOR's rights to enforce and sue for, and to receive monetary damages and equitable relief for, infringements of the trademark and trademark registration listed in Schedule A which occurred prior to the date of this assignment.

ASSIGNOR retains no ownership rights in the trademark, trademark registration and rights transferred to ASSIGNEE by this assignment.

This Assignment is effective as of January 1, 1995.


