WHEREAS, Assignor has acquired goodwill associated with and symbolized by the Trademarks and has not abandoned same;



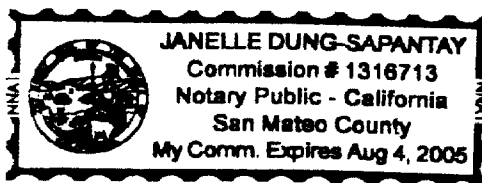
