## TERMINATION OF TRADEMARK ASSIGNMENT

This Termination of Trademark Assignment is granted as of June 14, 2002 by SUN CATALINA HOLDINGS, LLC, a Delaware limited liability company ("Sun Catalina"), in favor of CATALINA LIGHTING, INC., a Florida corporation (the "Company"). (Sun Catalina and the Company together are sometimes referred to herein as the "Parties").

WHEREAS, Sun Catalina and the Company entered into an Intellectual Property Security Agreement (the "IP Security Agreement") on July 23, 2001;


WHEREAS, pursuant to the terms of the IP Security Agreement, Sun Catalina and the Company entered into a Trademark Assignment (the "Assignment") on July 23, 2001, under which the Company assigned and transferred to Sun Catalina the entire right, title, and interest of the Company in and to the trademarks listed on Schedule A hereto (hereinafter, the "Marks"), including the common law rights, the federal registrations of the registered Marks, and all goodwill of the business connected with the Marks;

WHEREAS, the United States Patent and Trademark Office recorded the Assignment on August 15, 2001, against the Marks listed on Schedule A; and

WHEREAS, Sun Catalina and the Company entered into a Stock Purchase Agreement on June 14, 2002 (the "Agreement"), the terms of which Agreement acknowledge that the Company has satisfied all outstanding obligations under the IP Security Agreement, and the Parties seek to make a record of the termination of the Assignment and Sun Catalina's transfer and reassignment to the Company of any and all of its interest in the Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the Parties acknowledge, Sun Catalina hereby transfers and reassigns to the Company all right, title, and interest that Sun Catalina may have had in and to the Marks, including the common law rights, the federal registrations of the registered Marks, all goodwill of the business connected with the Marks, and the right to sue for and receive all damages from past, present, and future infringements, and the proceeds thereof. Sun Catalina specifically acknowledges that the IP Security Agreement is no longer effective, that the Assignment is hereby terminated, and that Sun Catalina does not own any rights to or have any ownership interest in the Marks, and that all of its rights and remedies with respect to the Marks have been and are hereby extinguished.
