**CONFIRMATORY TRADEMARK ASSIGNMENT**

WHEREAS, AT PLASTICS INC., an Ontario corporation, and AT PLASTICS CORP., a North Carolina corporation (collectively the "Purchasers") obtained an assignment from SILOFLEX CORPORATION, a Minnesota corporation ("Old Siloflex") of all of the rights of Old Siloflex to the Trade Mark **SILOFLEX** registered on the Principal Register of the U.S. Patent and Trademark Office as Reg. No. 2,201,059, and all depictions thereof and logos related thereto (the "Trademark") pursuant to a Trade Mark Sale Agreement dated as of 31st day of December, 1998 (the "Sale Agreement"); and

WHEREAS, previous to the Sale Agreement, the Purchasers had, among other things, procured the acquisition of Old Siloflex's bag-folding machines and all associated know-how of Solamer Corporation; and

WHEREAS, the Purchasers intended that, as between them, the Trademark, together with the goodwill of the business symbolized by it, and the U.S. registration of it, was to be owned by AT PLASTICS INC., and AT PLASTICS CORP. never regarded itself as the owner; and


WHEREAS, AT PLASTICS INC. desires to confirm its continued ownership of the Trademark, and to acquire all of AT PLASTICS CORP.'s right, title and interest in and to the Trademark, together with the goodwill of the business symbolized by it as well as the U.S. registration of it and all common law and statutory rights with respect to the Trademark;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, AT PLASTICS CORP. does hereby confirm that it has assigned, and does hereby assign, unto **AT PLASTICS INC.**, of 142 Kennedy Road South, Brampton, Ontario L6W 3G4, Canada, its successors and assigns, absolutely and forever, all of its right, title and interest in and to the Trademark together with the goodwill of the business symbolized by the Trademark, and the above-identified registration thereof, as well as the right to take legal action against infringements occurring either before or after the date of this assignment, and to collect and retain all monetary and other benefits derived therefrom, effective as of December 31, 1998.
