2. The text of the amendment adopted is as follows:

RESOLVED, that the Articles of Incorporation of this corporation be amended by deleting ARTICLE FIRST thereof in its entirety and by inserting, in lieu thereof, the following new ARTICLE FIRST:

The name of the corporation is:


