

Whereas Assignor is the owner of and has used and is using in its business certain trademarks which are registered in the United States Patent and Trademark Office and bear the registration numbers and registration dates listed in paragraph 3 of this Assignment.

Whereas Assignee is desirous of acquiring Assignor's right, title and interest in and to said trademarks, and the goodwill of Assignor's business symbolized by such trademarks, and said registrations ;




