TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

River Ranch Fresh Foods-Salinas, Inc.

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of June 17 2002, by **BANC OF AMERICA SECURITIES LIMITED**, in its capacity as security trustee under a certain Security Agreement dated February 19, 2002, among it, and River Ranch Fresh Foods-Salinas, Inc. (together with its successors and assigns, the "Security Trustee") in favor of **RIVER RANCH FRESH FOODS-SALINAS, INC.**, a corporation, having its principal place of business at 1156 Abbott Street, Salinas, California ("River Ranch").

WHEREAS, River Ranch and the Security Trustee entered into a Trademark Security Agreement dated as of February 19, 2002 (the "Trademark Agreement"), which Trademark Agreement was recorded with the United States Patent and Trademark Office on April 4, 2002, for the purpose of securing the obligations of River Ranch to the Security Trustee;


WHEREAS, pursuant to the Trademark Agreement, River Ranch granted to the Security Trustee a continuing security interest in and first priority lien on all the Trademarks (as defined in the Trademark Agreement and attached hereto as Exhibit A), and pledged, mortgaged and hypothecated (but did not transfer title to) the Trademarks to the Security Trustee;

NOW, THEREFORE, for valuable consideration and pursuant to the terms and conditions set forth in the Trademark Agreement:

The Security Trustee hereby terminates and releases the security interest granted to it by River Ranch on all of the Trademarks, and the Security Trustee hereby assigns and transfers to River Ranch, without recourse, all of the right and interest granted to it by River Ranch in the Trademarks, effective as of the date set forth above.


