**TERMINATION
OF
SECURITY INTEREST IN TRADEMARKS**

This Termination of Security Interest in Trademarks (hereafter, the "Termination") is executed on behalf of Morgenthaler Partners VI, L.P., as collateral agent ("Secured Party"), in favor of Peregrine Semiconductor Corporation, a Delaware corporation ("Debtor").

RECITALS

A. Debtor and the Secured Party entered into a certain Security Agreement, dated as of February 8, 2002 (as amended, modified or supplemented from time to time, the "Security Agreement"), in favor of Secured Party as collateral agent for itself and the Lenders (as defined in the Security Agreement).

B. Pursuant to the Security Agreement, Debtor granted to the Secured Party a security interest into certain Intellectual Property under a Grant of Security Interest, dated as of February 8, 2002.

C. The Grant of Security Interest was filed with a Recordation Form Cover Sheet with the Patent and Trademark Office on February 12, 2002.

D. Debtor has repaid all amounts due under the Agreement.

The Secured Party therefore expressly terminates its security interest in the Collateral, including without limitation, the trademarks and trademark applications listed on Schedule "A" hereto.


Unless otherwise defined herein, all other capitalized terms used herein and defined in the Termination shall have the respective meanings given to those terms in the Security Agreement.
