RELEASE OF TRADEMARK COLLATERAL

THIS RELEASE OF TRADEMARK COLLATERAL (this "Release") is made as of July 2, 2002, by GUARANTY BUSINESS CREDIT CORPORATION ("GBCC"), the secured party under that certain Security Agreement referred to below.

W I T N E S S E T H:

WHEREAS, VeriFone, Inc., a Delaware corporation ("VeriFone"), executed that certain Security Agreement (Intellectual Property) (the "Security Agreement") dated as of January 18, 2002 pursuant to which VeriFone granted a security interest to GBCC in certain trademarks and other intellectual property of VeriFone; and

WHEREAS, said Security Agreement was recorded with the Assignment Branch of the United States Patent and Trademark Office at Reel 2447, Frame 0197 on February 27, 2002; and

WHEREAS, GBCC has agreed to release all its rights under such Security Agreement, including, without limitation, in the trademarks identified on Exhibit A attached hereto and made a part hereof (the "Released Collateral"), and to reconvey any and all rights in the Released Collateral to VeriFone.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, GBCC hereby releases all its rights in and to the Released Collateral, reconveys to the persons legally entitled thereto all of GBCC's right, title and interest in and to the Released Collateral, releases all other rights it may have under said Security Agreement with respect to the Released Collateral and cancels such Security Agreement in its entirety, all without warranty or representation of any kind.


