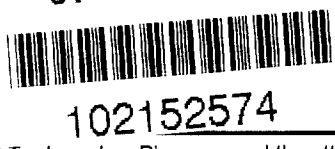

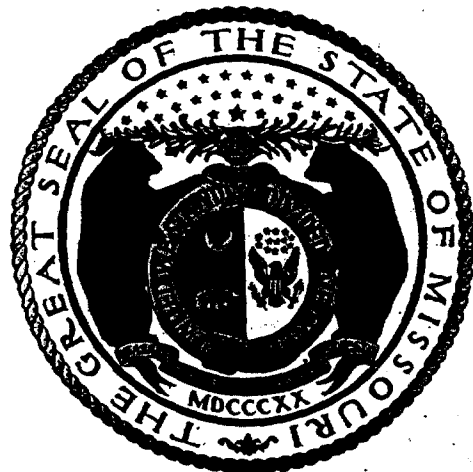

AMENDMENT TO ARTICLES OF INCORPORATION  
OF  
INTERTECH MANAGEMENT GROUP, INC.

Pursuant to the provisions of the General and Business Corporation Law of Missouri, the undersigned Corporation certifies the following:

1. The present name of the Corporation is Intertech Management Group, Inc.

The name under which it was originally organized was Intertech Management Group, Inc.

2. An Amendment to the Corporation's Articles of Incorporation was adopted by the shareholders on February 16, 2001.

3. Article Number One is amended to read as follows:

The name of the Corporation is Abiliti Solutions, Inc.

4. Of the 6,336,794 shares of Common Stock outstanding, 6,336,794 of such shares were entitled to vote on such amendment.

Of the 2,792,819 shares of Series A Preferred Stock outstanding, 2,792,819 of such shares were entitled to vote.

Of the 1,328,383 shares of Series B Preferred Stock outstanding, 1,328,383 of such shares were entitled to vote.

All common and preferred shares outstanding were entitled to vote as a single class on the amendment.

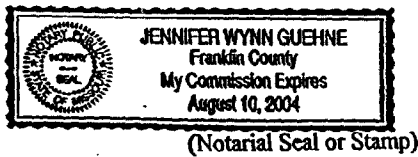
