This RELEASE is granted as of January 31, 2002 by FLEETBOSTON FINANCIAL CORPORATION f/k/a BANKBOSTON, N.A., located at 100 Federal Street, Boston, Massachusetts 02110, ("Assignor") as agent for the benefit of the various financial institutions who are parties to the Credit Agreement dated December 23, 1998 among Assignor, such financial institutions, and LA SALSA HOLDING CO., LA SALSA FRANCHISE, INC. and LA SALSA OF NEVADA, INC., (collectively, the "Assignees").
