**NUNC PRO TUNC ASSIGNMENT**

WHEREAS, pursuant to that Asset Purchase Agreement dated July 8th, 1993 by and among R.G.B. Laboratories, Inc., a Missouri corporation, Presto Food Products, Inc., a California corporation, and American Micronutrients, Inc., a Delaware corporation, all rights in the AGRI-PLEX trademark and the goodwill of the business symbolized thereby, along with U.S. Registration No. 1,188,290, were assigned from R.G.B. Laboratories, Inc. to American Micronutrients, Inc.;

WHEREAS, American Micronutrients, Inc. subsequently transferred certain assets, including said AGRI-PLEX trademark and registration, to Lisa Products Corporation, a Delaware corporation;


WHEREAS, because Presto Food Products, Inc. was the record owner of said registration in the United States Patent and Trademark Office a document entitled Assignment of Trademark, dated November 15, 1995, was subsequently executed by Presto Food Products, Inc. for use in recording with the United States Patent and Trademark Office for the purpose of evidencing transfer of ownership of the AGRI-PLEX trademark and registration to said Lisa Products Corporation;

WHEREAS, the aforesaid Assignment of Trademark mistakenly identified the assignee as Lisa Products Inc. rather than Lisa Products Corporation.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Presto Food Products, Inc. does hereby revoke the aforesaid Assignment of Trademark and does now by these presents, nunc pro tunc, to be effective November 15, 1995, transfer, convey and assign to said Lisa Products Corporation the entire right, title and interest in and to said AGRI-PLEX trademark and said registration, together with the goodwill of the business associated therewith, including the right to recover for past infringement of said trademark.
