
TRADEMARK ASSIGNMENT

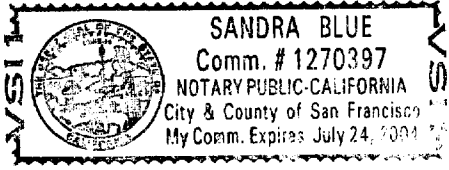

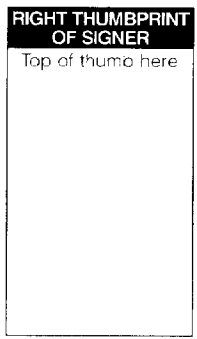
