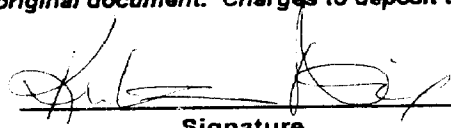

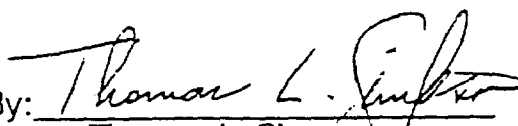

"The name of the Corporation is Unisource Worldwide, Inc."

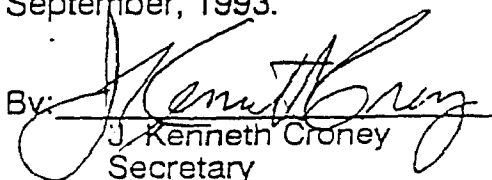
