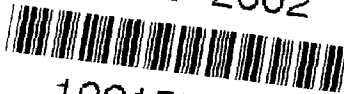

ASSIGNMENT

WHEREAS, Scion Photonics, Inc., a Delaware Corporation having offices at 345 Los Coches Street, Milpitas, California ("SCION") has adopted, used, and owns by common law, assignment, or otherwise all right, title, and interest in the Common Law Trademarks and/or Service Marks, and corresponding U.S. Trademark and/or Service Mark Applications of Exhibit "A," (collectively "Marks") along with any and all goodwill associated therewith; and

JDS Uniphase Corporation, a Delaware corporation having offices at 1768 Automation Parkway, San Jose, California ("JDSU"), desires to own SCION's entire right, title, and interest in and to these Marks and their associated goodwill, in all countries throughout the world.

NOW THEREFORE, be it known that, for good and valuable consideration, receipt of which is hereby acknowledged, SCION hereby sells, assigns, transfers, and sets over to JDSU, its lawful successors and assigns, SCION's entire right, title, and interest in and to the Marks listed on Exhibit A together with all goodwill associated therewith, and all Registrations that may be granted thereon, and all divisions, renewals and extensions thereof; and all rights to claim priority on the basis of such applications, and all applications that may be filed in any foreign country and all Registrations that may be granted in any foreign country, and all divisions, renewals and extensions thereof; and SCION hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and any official of any foreign country whose duty it is to issue Registrations on applications as described above, to issue all Registrations to JDSU, its successors and assigns, in accordance with the terms of this Assignment;

AND, SCION HEREBY further covenants that SCION has the full right to convey the interest assigned by this Assignment, SCION will take all action and execute all documents necessary to perfect the interest assigned hereby, and SCION has not executed and will not execute any agreement in conflict with this Assignment;

AND, SCION HEREBY further covenants and agrees that SCION, through its officers and employees, will communicate with JDSU, its successors and assigns, any facts known to SCION and its officers and employees respecting the Marks and testify in any legal proceeding, sign all lawful papers when called upon to do so, execute and deliver all papers that may be necessary or desirable to perfect the title to the Marks in JDSU, its successors and assigns, execute all extension, renewal and divisional applications, make all rightful oaths, and generally do everything reasonably necessary to aid JDSU, its successors and assigns, to obtain and enforce proper protection for the Marks in the United States and any foreign country, it being understood that any reasonable expense incident to the execution of such actions shall be borne by JDSU, its successors and assigns.
