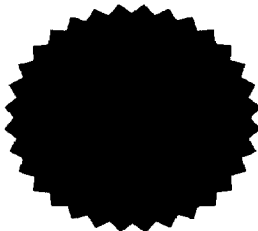


**"FIRST:** The name of the corporation is **METSO MINERALS INDUSTRIES, INC. "**
