ASSIGNMENT OF MARK

THIS ASSIGNMENT OF MARKS (this "Assignment"), dated as of the 12th day of April, 2002, is by and between GREGG SMITH an Individual ("Assignor"), and The Association of Brewers, Inc. a Colorado Corporation ("Assignee").

WITNESSETH:

WHEREAS, Assignor and Assignee entered into an Agreement (the "Agreement"), dated April 12, 2002, pursuant to which Assignor agreed to convey, sell, transfer and deliver to Assignee and its successors and assigns, all right, title and interest of Assignor in and to a certain service mark registered in the U.S. Patent and Trademark Office at Reg. WHEREAS, Assignee desires to acquire all right, title and interest of Assignor in and to the Mark.



NOW, THEREFORE, in consideration of the premises and agreements set forth herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. **Assignment**. In consideration for the payment by Assignee to Assignor pursuant to the Agreement, the receipt of which is hereby acknowledged by Assignor, Assignor hereby sells, conveys, assigns and transfers to Assignee all right, title and interest of Assignor in and to the Mark, together with all of the goodwill appurtenant thereto, including, without limitation, (a) the registrations for the Mark in the U.S. Patent and Trademark Office and any renewals and extensions of the registrations for the Mark, (b) any rights to file for foreign registrations of the Mark and (c) the right to any causes of action, in law or in equity, for past, present or future infringement of the Mark.
2. **Choice of Law** The validity of this Assignment shall be governed by the laws of the State of Colorado without regard to its conflicts of laws rules.
3. **Successors and Assigns**. This Assignment shall inure to the benefit of and shall be binding upon the parties hereto, their successors, transferees and assigns.
4. **Counterparts** This Assignment may be executed in multiple counterparts, each of which shall be deemed an original and all of which taken together shall constitute one and the same document.



